# CITY OF FORT BRAGG APPLICATION FOR POLICE ENFORCEMENT OF RESTRICTED PARKING ON PRIVATE PROPERTY

Fort Bragg Municipal Code 10.20.035 and California Vehicle Code 21107.8 provide that the Police Department may enforce traffic and parking regulations on privately-owned parking lots if the following conditions are met:

- 1. The facility must be listed in a resolution authorizing enforcement adopted by the City Council.
- 2. Signs which meet the specifications attached must be "posted in a conspicuous place at each entrance" and maintained by property owner (CVC 21107.8b).
- 3. This application must be submitted to the Office of the City Clerk not less than 30 days prior to the date upon which enforcement is requested to commence.

# IMPORTANT INFORMATION/SPECIFICATIONS

LETTERS: 1-inch MINIMUM height.

SIGN SIZE: 17" by 22" MINIMUM overall.

Signs can be consolidated (i.e., a business may wish to have "Customer Parking Only" and "No Parking" during closed hours). This can be accomplished by combining Signs "A" and "B".

MAINTENANCE: If not maintained, enforcement will be discontinued.

Enforcement of "A" and "C" will be by complaint from the property owner or manager only.

Regulations apply to ALL vehicles, even those owned by property owner/manager/employees.

Signs must be made by applicants. The City does not provide these signs.

PROCESS; This item will go to review by the Traffic Committee. Following approval there, it will be approved at a City Council meeting and added to the City's Master Traffic Resolution. The Police Department will have copies available of said resolution in order to verify enforcement requests.
