


Department Summary

The Fort Bragg Police Department is made of up 21 full-time employees. Chief Fabian Lizarraga, Lieutenant Charles Gilchrist, Administrative Coordinator Debbie Desmond, Police Service Technician/Records Supervisor Sally Provencher and Police Service Technician/Property & Evidence Tech Gretchen Leinen make up the Administrative Division. Along with administrative responsibilities the Administrative Division is responsible for records management, property and evidence management, Live Scan services and other duties. The Operations Division is comprised of 3 Sergeants, 11 full-time sworn Police Officers, and 3 Community Service Officers. The Operations Division is tasked with handling all items related to the enforcement of laws.

The Fort Bragg Police Department is the only law enforcement agency on the California coast between Eureka and the San Francisco Bay Area with sworn law enforcement officers on duty 24 hours per day. The Police Department is divided into 4 teams, each working 12-hour shifts. Police Officers respond to a variety of calls for service, including criminal and non-criminal incidents. Examples of criminal incidents include assault/battery, domestic violence, burglaries and public intoxication. Examples of non-criminal incidents include non-DUI traffic collisions, civil disputes, and landlord-tenant disputes.

Fire Safety Day



In 2014, the Fort Bragg Police Department conducted a recruitment for Police Officer Cadet, for which the successful candidate would be afforded the opportunity to attend the six month long Santa Rosa Junior College Basic Police Academy, fully sponsored by the City of Fort Bragg. This recruitment process was implemented several years ago in order for the City of Fort Bragg to recruit local talent to staff its police department and maintain some much needed staffing retention and stability among the ranks.

Fort Bragg High School graduate and multi-generational Fort Bragg resident, Brandon McGregor, was found to have an interest in law enforcement, and participated in the rigorous testing and screening for the cadet recruitment. Brandon was successfully chosen during the final selection process, and began the intensive and demanding training at the Santa Rosa Academy in July of 2014. Six months later, Brandon emerged successful, and returned back to Fort Bragg in December of 2014 to begin the challenge of proving his newly acquired knowledge and skills in the Fort Bragg Police Department Field Training Program.

Brandon began the Field Training Program with the Fort Bragg Police Department in January of 2015, and successfully completed the challenging 18 week training and assessment in late April 2015. Brandon has been serving the City of Fort Bragg as a Solo Police Officer since May 2015, and has grown to be a diligent, respectful, and well liked officer within the department and throughout the community.

Brandon is the second member of his family to serve the City of Fort Bragg's Police Department. Brandon's mother, Peggy Mello, served the Fort Bragg Police Department in the earlier 2000's as Fort Bragg Police Department's first Community Service Officer. Peggy later moved on to serve in the Mendocino County Court System, where she still serves today in the Ukiah Superior Court.

The Fort Bragg Police Department is honored and grateful to find talented locals such as Brandon McGregor who are willing to serve and protect the community they were raised in, and that helped raise them into respectful, law abiding citizens.

The Fort Bragg Police Dept. currently maintains 6 Fort Bragg High School graduates on its staff.

Officer O'Neal began his career with the Fort Bragg Police Department on 7/15/13. Prior to his law enforcement career, he served from 2002—2013 in the United States Army as an Air Defense Operator and a Supply Logistics Officer.

Officer Melendez began his career with the Fort Bragg Police Department on 5/5/14. He graduated from the Santa Rosa Junior College Public Safety Academy in 2012. Prior to attending the academy, Officer Melendez was a martial arts instructor.

In Remembrance



The Fort Bragg Police Department would like to recognize and remember a wonderful man and a dedicated Police Officer, Ricky Delfiorentino. Ricky was ambushed and killed while performing his duties as a Deputy for the Mendocino County Sheriff's Office on March 19, 2014.

Ricky was born in Napa, CA on May 28, 1965 where he attended school and received a wrestling scholarship to Oklahoma University. After returning to California he attended Napa Valley College Police Academy, launching his career into police work.

He began his law enforcement career with the Mendocino County Sheriff's Office in 1988 as a Deputy Sheriff. During the Mendocino County budget crisis in 1990 Ricky went to work for the Fort Bragg Police Department where he served for the next 10 years as a Police Officer and a Detective. He returned to the Mendocino County Sheriff's Office in May of 2000.

Ricky was inducted into the Napa High School Athletic Hall of Fame in 1998 and was a Police Olympics Gold Medal winner in 2003 in both Greco Roman and Freestyle wrestling.

Ricky loved the outdoors and spent most vacations in Oregon hunting and fishing with his family. He loved the Oregon area where he had planned to retire.

Ricky also coached middle school and high school wrestling and was the President of the Coast Police Activities League.

He loved to cook as well as eat. Ricky had the ability to fashion a meal out of just about any ingredients he had lying around. Sometimes you weren't sure if you wanted to eat it, but in most instances it was quite tasty.

Ricky loved spending time with his family and was extremely proud of his children, Mika, Hailey, Tim, Dahl and Lexie. His wife Beth was the love of his life and his best friend. Ricky considered his friends part of his family and loved every one of them.


Ricky was loved by everybody and judged no one. He often put others' needs before his own and would reach out to people in need that he didn't even know.


Ricky was a gentle giant with a heart of gold and a smile that would light up any room. His distinguished laugh will continue to echo through our minds for many years to come.



Call for Service

In 2013, Fort Bragg Police Officers responded to a total of 17,255 calls for service and wrote 1,925 Crime Reports associated with those calls for service, which resulted in 588 arrests. In 2014, Fort Bragg Police Officers responded to a total of 16,446 calls for service and wrote 1,680 Crime Reports associated with those calls for service, which resulted in 579 arrests.







Traffic Safety

A major concern for the Fort Bragg Police Department and community alike is traffic safety. There have been many street improvements in recent years, increasing the safety of motorists traveling within Fort Bragg city limits.

The Fort Bragg Police Department initiates traffic stops on traffic safety violators with the purpose of education and enforcement. These two aspects combined lead to greater driver awareness and an ultimate goal of decreasing traffic collisions, thus increasing traffic safety in our community. 




Gang Crime


Criminal Street Gangs present a threat to the safety of law enforcement and the community alike. Criminal Street Gangs are responsible for drug sales and trafficking, weapons violations, property crimes for the benefit of the gang, violence against citizenry, law enforcement and rival gang members, rape, and murder.


Property Crime

Crimes against Persons

Over the last four years, the City of Fort Bragg remained a safe place to live. The number of homicides remained the same at one while robberies showed a steady increase. Reported rapes fluctuated. Reports taken for Murder, Manslaughter, Rape, and Robbery from the 2011 through 2014 are as follows:



Assaults can refer to many different types of crimes against persons, including but not limited to gang fighting, simple or aggravated battery and domestic violence assaults. The year 2013 showed a slight increase in assaults from the previous two years, but still remained comparatively low. There was a slight decrease in assaults in 2014.
