All vendors are welcome, whether it be handmade goods, clothing, or food, as long as it's fall, Halloween, or just plain magical themed.

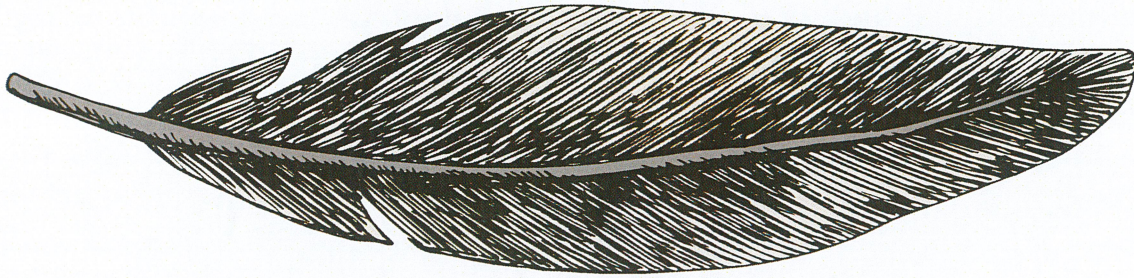
