Main Street), Fort Bragg, California 95437. The public hearing will concern the following:

The public hearing will be open for public participation. All interested persons are invited to present oral or written comments at the public hearing. Written comments can also be submitted by mailing them to the City Clerk at 416 N. Franklin Street, Fort Bragg, CA 95437 or emailing them to <a href="mailto:dsanchez@fortbragg.com">dsanchez@fortbragg.com</a>. To be made a part of the record of the public hearing, such mailed or emailed comments must be received by the City Clerk no later than 4:00 PM on the date of the public hearing.

The following will be made available for public review at least 14 days prior to the public hearing: (i) data indicating amount of cost or estimated cost required to provide the public facilities ("services") for which each capacity charge/impact fee is levied and the revenue sources anticipated to provide the service and (ii) evidence to support that the charge/fee does not exceed the estimated reasonable cost of providing these services will be made available to the public for review at least fourteen days prior to the public hearing. The resolution, ordinance and additional information that will be considered by the City Council will be available for review 72 hours prior to the hearing date. All information described in this paragraph will be available for review and for copying at the Office of the City Clerk, City Hall, 416 North Franklin Street, Fort Bragg, California 95437 during normal business hours. To expedite our ability to serve you, you can call 707-961-2823, ext. 102 to schedule an appointment.
